6. Qualifications requirements (financial capacity, experience and technical capacity of the Bidder) for each of the five Lots are specified in Section III, Evaluation and Qualification Criteria of the Bidding Documents.

For the purposes of establishing Bidder's qualifications, the financial and technical capacity of any Subcontractor will not contribute to the Bidder's qualifications.

A margin of preference for certain goods manufactured domestically shall not be applied.
